TERMS AND CONDITIONS FOR FAMILY CYCLE FUN DAY 19TH MARCH 2017

1. Acceptance of Conditions

- 1.1 For the wellbeing of all entrants, and of the event, all entrants must accept and comply with all event conditions.
- 1.2 I accept that it is my responsibility to contact the event organisers should any information on my entry form need to be updated eg: emergency contact details.

2. Route Variation

- 2.1 The organisers of the Family Cycle Fun Day reserve the right to vary the route of any of the events without notice, should any such action arise.

3. Expected Behavior

- 3.1 The Family Cycle Fun Day is a communal event, and as such it is expected that entrants will conduct themselves in a manner which reflects well upon themselves and the day. It is expected that entrants will show respect towards all event officials, marshals and security personnel. A belief in what a reasonable person would find offensive or dangerous will guide the organiser's decision making.
- 3.2 No athlete that is currently serving a ban for an anti doping rule violation may enter this event.

4. Preparation and Training

- 4.1 It is each entrant's responsibility to ensure that they have adequately prepared themselves physically for their selected event. If you have any health issues or doubts about your health you should seek medical advice. Please ensure you take any necessary medication with you on the ride and note any medical conditions on the back of your event bib.
- 4.2 It is the entrant's responsibility to ensure that their bicycle and any other equipment used in the event are in road-worthy condition.

5. Event Information

- 5.1 The event organisers publish a number of documents, in the form of information sheets and on the event website. The organisers will make every effort to ensure that each entrant receives all relevant information, but does not guarantee that each individual will receive all the relevant information. It is each entrant's responsibility to be informed and read all information made available. Each entrant will accept that all instructions, whether written or verbal, are clear and unambiguous.
- 5.2 The Family Cycle Fun Day collects and stores entrants details including postal address, email address and phone number. Entrants agree that these may be used to contact them regarding the event.
- 5.3 I hereby allow the use of my name and image to be used in the media and for marketing purposes. I understand and accept that my details will be added to the Family Cycle Fun Day event database and I will be contacted from time to time in regards to upcoming events and promotions.

6. Safety

- 6.1 When on the event entrants must obey the road rules and in particular must stay to the left of the centre line. Even where there is a road closure, entrants acknowledge that there is no guarantee that other members of the public will necessarily respect the road closure or obey the road rules. Entrants must comply with all directions of event officials, marshals and security personnel and with all event signage.
- 6.2 Every rider shall ride carefully and with due regard to the safety of other cyclists and other road users.
- 6.3 Each entrant must accept that despite the best efforts of the organisers to make the event as safe as they can, organisers cannot control everything.
- 6.4 Every rider shall wear a bicycle helmet with the strap securely fastened under his/her chin.
- 6.5 A rider may not use a personal music system eg. ipod or a radio communication device, including a cellular phone whilst riding.
- 6.6 An entrant must notify the organisers if withdrawing from the event for any reasons either prior to or during the event.

7. Legal Issues

- 7.1 Any entrant involved in an accident will not seek to blame or make a claim against the organisers or assist anyone else in making a claim.
- 7.2 Each entrant will release the organisers, their officers, volunteers, employees, sponsors or any party associated with the event or its related activities.
- 7.3 Any legal action related to the event will be taken in New Zealand courts under New Zealand law.
- 7.4 The waiver that you sign as a condition of entry does not cover personal liability of participants for collisions caused by yourself or another rider.

8. Event Care of Your Bicycle and Equipment

- It is the responsibility of all entrants to arrange personal insurance to cover any potential damage or loss of bikes and equipment while participating in the event.
- 8.2 The organisers of the Family Cycle Fun Day will take all care in handling riders, bikes and associated equipment. Any damage caused by event personnel must be reported to Event Headquarters for consideration on the day of the event.
 - 8.3 The legal liability of the Family Cycle Fun Day or any damage to a relay riders bike and/or equipment (only whilst being transported) is the limit under Carriage of Goods Act, which is \$2,000 per unit and any claims will be limited to this amount only.

9. Photography

- 9.1 Entrants must accept that they may be photographed or filmed during the event, and must agree to the creation and use of such footage for the future promotion and publicity of the event. Entrants also agree that Family Cycle Fun Day and/or its sponsors can use imagery of entrants.

10. Transfers, Cancellations and Refund Policy

- 10.1 In the event of a change of route, cancellation of the event due to any act beyond the power of the organisers, or dissatisfaction, the organisers are under no obligation to refund fees paid.

11. Disqualification from the Event

- 11.1 Any entrant who, in the opinion of the event organisers, fails to comply with these event conditions may be disqualified from the event. Disqualification will result in the offender's name being completely removed from the event database, including from the prize draw and may result in a refusal, by the event organisers, to accept entry to future Family Cycle Fun Days. No refund will be granted.
- 11.2 The event organiser reserves the right to refuse any person's entry up or cancel any persons entry up to the day before the Family Cycle Fun Day. In that event the person's entry fee will be refunded.

12. Start and Finish

The start will be one horn blast and the timed finish will be two horn blasts. Riders will complete the lap they are on to finish.

13. Signing on behalf of others

If you are completing this entry on behalf of others eg: relay team members, or on behalf of minors, then you must have them read these Terms and Conditions and obtain their permission (also in the case of a minor, their caregiver) to complete this entry on their behalf. By making the below Declaration, you will be deemed to be also making it on behalf of those persons and with their authority and they will be bound by these Terms and Conditions as if they had personally signed the Declaration.

14. Transferring Entry

- 14.1 If this entry is transferred to another person you must have the transferee read these terms and conditions as if they personally signed the declaration.

15. Electric Bikes

Electric bikes are not permitted as part of the event.

16. Relay Events

- (a) Youth: These are an adult rider with a youth rider. Adult riders will start first. Two riders per event and 1 lap each.
- (b) Open: A maximum of two riders and 1 lap each.

17. Start in Youth Events

Ages 12-14 will go first, followed by 9-11 and then 6-8 last.

18. Marshalling Area

All riders will be at the marshalling area 10 minutes before each event. Failure to do so may result in exclusion from that event.
